A Special Note about Outdoor Events:

Using professional audio equipment strategically placed, Steve Buerer Video has filmed many outdoor events with great success. However, while we use the quality audio and video equipment, wind and/or other weather and location circumstances may make it very difficult to capture audio with complete clarity. We will make every effort on our part to capture the clearest audio possible on your event day. Please keep this in mind when your final video arrives.

TERMS AND CONDITIONS

Service. Steve Buerer Video agrees to provide coverage outlined above on the date indicated on page 5 (5) of this contract. Steve Buerer Video will video record using its best judgment, providing Client with completed event video in DVD format unless otherwise stipulated in this agreement.

Terms and Payments. The first payment due upon booking is a retainer fee of one-third of the total and not less than \$250.00. This payment is to secure the date for the event. This payment is non-refundable for any circumstances. If the event is cancelled or the date is changed, the initial payment may be forfeited. An additional retainer may required to secure a new event date. No later than 6 weeks prior to the event date, any remaining balance is due. If this payment is not received by said due date, your date is no longer considered secure, and previous payments may be forfeited. Steve Buerer Video will accept payments by money order, personal check, cash or credit card. If paying by check, date will not be considered secure, and all final products will be held until check has cleared. If any check is returned for nonpayment, Client will pay a \$30.00 returned check fee. No date shall be considered secure until new payment is received and all payment is cleared. A 5% discount is given for CASH paid with the signed contract when paid in full in cash

Permissions. It is the sole responsibility of the Client to secure advanced permission from ALL locations, including hair locations, church, synagogue or other officials, and reception sites. All money paid is non-refundable if any officials prevent filming the day of the event. Steve Buerer Video will abide by the rules of the church or synagogue regarding camera placement at the ceremony, and any such rules at other locations the day of event. Steve Buerer Video is not responsible for loss of video or audio quality due to restrictions at event locations, and cannot refund money paid if client does not secure permissions from the church, synagogue or other officials.

Limitation of Liability. Under any and all circumstances, the total liability of Steve Buerer Video is limited to the refund of actual payments received from Client. In the unlikely event that a problem arises whether due to lateness, no show, accident, neglect, human error, loss of materials, acts of God, power loss by utility companies, wireless microphone interference, equipment or other failures and Steve Buerer Video is unable to provide ANY video or digital video coverage, all payments will be refunded. Steve Buerer Video will not be held liable for any footage not captured due to restrictions placed on Steve Buerer Video by event officials or venue restrictions or interferences from guests, participants or other vendors; I.E., photographers; professional or non-professional.

Original Footage. Original footage is the sole property of Steve Buerer Video. Client agrees to surrender all creative control to Steve Buerer Video for editing purposes. Original files will be kept for 60 days after final video delivery to client. After 60 days, Steve Buerer Video reserves the right to destroy or delete original files, keeping only a copy of client's completed video for future DVD purchases. Steve Buerer Video reserves the ownership of all original footage and use of said footage for purposes including, but not limited to display, publication, exhibition, promotion, and advertising.

Editing. Client agrees that Steve Buerer Video may use its best judgment in editing the completed Event Video and surrenders full creative control to Steve Buerer Video. Once final delivery is complete, client has 30 days to report any errors in spelling, faulty DVDs or BluRays, or non-creative problems. If client requests any additional editing, including but not limited to changes in music or the removal of unwanted comments from family or guests, the charge is \$70.00 per hour, with a 2-hour minimum. Any requests for editing changes MUST be made in writing, within 30 days of the final delivery date. After 30 days, Steve Buerer Video reserves the right to destroy or delete original footage. Model's Release and Promotional Material. Client grants Steve Buerer Video a Model's Release for all purposes. Client agrees to indemnify and hold harmless Steve Buerer Video from any action by a person at their event whose image is used by Steve Buerer Video and from whom Steve Buerer Video does not have model's release. Initial here When you have read this. _____

Broadcast Use. Client shall not use any portion of their video for broadcast purposes, including posting to YouTube, Facebook, Vimeo or similar. Broadcasting methods are to be done at the sole discretion of Steve Buerer Video- Permission is granted to use the videos online if signed by Steve Buerer _____

Music and Copyright. Steve Buerer Video will use their best judgment when choosing music for the final event video. Client may supply songs, or may request that particular songs or genres of music be excluded from their video, but such requests must be made in writing on or before the day of the event listed in this contract. Any requests made after this date will result in additional editing costs to change or alter music in the video. Client is responsible for all copyright issues regarding the music that they choose or that is chosen for them on their behalf.

Cancellation. If Client cancels this contract, Steve Buerer Video may keep any payments as liquidated damages. If client chooses to cancel, a cancellation agreement must be signed by both parties to relieve everyone of any further payments due. If Client fails to make payments as agreed this contract is cancelled and Steve Buerer Video is relieved of any further responsibility to Client, as well as any payments from the Client to Steve Buerer Video shall be retained as liquidated damages.

Entire Agreement. This agreement represents the entire agreement between Steve Buerer Video and Client, and includes all representations and negotiations of the parties. No verbal representations are binding upon the parties. Any additions to or modifications to this agreement must be in writing and agreed upon by both parties. This agreement shall extend to and be binding upon heirs and personal representatives of the parties. In the event attorney's fees are incurred by Steve Buerer Video to enforce its rights under this agreement, Client shall pay all costs and reasonable attorney's fees incurred by Steve Buerer Video.

Client and Steve Buerer Video. Throughout this agreement, the term Client refers to the Persons indicated on page one (1) of this contract and/or any other representative signing this contract on their behalf. Throughout this agreement, Steve Buerer Video refers to Steve Buerer and any person working with him or representing him for the event named in this contract.

Safety. In the event that those attending become , and in the judgment of Steve Buerer Video, give cause for concern for the safety of the equipment, persons or increased liability by irresponsibly behavior of those attending, Steve Buerer or his representative will notify the event coordinator or host of the issue. If the situation is not corrected, in the opinion of Steve Buerer, equipment will be removed. In the event that the audio goes above 100db as measured on the dB meter app, The Steve Buerer may end the evening's recording.
